

As part of our "return to work" approach following the suspension of work on our pit and pipe infrastructure due to issues around asbestos-containing material (ACM), we have required our existing contractors to undergo a rigorous verification process before authorising their personnel to recommence ACM works.

At this time, the following contractors have obtained authorisations for individual personnel to recommence ACM work on Telstra pit and pipe infrastructure. We note this process is ongoing and this list will be periodically updated:
